**FILING OF MOTIONS**

- \$ 15 - TO CONVERT CASE TO A CHAPTER 7
- \$645- TO CONVERT CASE TO A CHAPTER 11
- \$155 - TO REOPEN A CHAPTER 7 OR 13
- \$800 - TO REOPEN A CHAPTER 11
- \$ 25 - PRO HAC VICE

- \$255 - FILING AN APPEAL
- \$250 - FILING A CROSS APPEAL
