NOTICE TO THE BAR AND THE PUBLIC REGARDING CHANGES TO OFFICIAL BANKRUPTCY FORMS ON FEBRUARY 19, 2020; CM/ECF MAINTENANCE AT 10:00 PM (EASTERN) ON FEBRUARY 18, 2020; AND REVISIONS TO APPENDICES "M" AND "N" OF THE LOCAL RULES OF BANKRUPTCY PROCEDURE

Please Be Advised and Take Notice:

- I. **OFFICIAL FORMS**. The Small Business Reorganization Act of 2019 (SBRA) takes effect on February 19, 2020. In connection with the new law, several bankruptcy official forms were updated and will also take effect on the same date. Of note, a few frequently used official forms with revisions are:
 - **B309E** and **B309F**: Notices of Chapter 11 Bankruptcy Case (v. 02/20). Official Forms 309E and 309F were modified in the following manner:
 - The original Official Forms 309E and 309F are re-numbered as 309E1 and 309F1, respectively, and other minor changes were stylistic.
 - 309E2 and 309F2 are created for the new provisions in Chapter 11, subchapter V.
 - 309E1 and 309E2 are for Individuals or Joint Debtors (v. 02/20)
 - 309F1 and 309F2 are for Corporations or Partnerships (v. 02/20)
 - **B101**: Voluntary Petition for Individuals Filing for Bankruptcy (v. 02/20)
 - **B201**: Voluntary Petition for Non-Individuals Filing for Bankruptcy (v. 02/20)

Effective February 19, 2020, version "02/20" of Official Forms B101 and B201 must be used. The Clerk's Office will monitor filings of official forms for proper version dates. On or after February 19, 2020, any filers using older versions of official forms will receive deficiency notices for the obsolete versions. Please take care to update your software and forms with current versions of the official forms.

In addition, the following official forms also received revisions, but note that the Federal Rules of Bankruptcy Procedure or the official form instructions permit alteration or a court approved form that conform substantially to the appropriate official form.

- **B314**: Class [] Ballot for Accepting or Rejecting Plan of Reorganization (v. 02/20)
- **B315**: Order Confirming Plan (v. 02/20)
- **B425A**: Plan of Reorganization for Small Business Under Chapter 11 (v. 02/20)

- II. CM/ECF OUTAGE. CM/ECF for the U.S. Bankruptcy Court for the District of Connecticut will be offline for system maintenance between 10:00 PM (Eastern), February 18, 2020, and 1:00 AM (Eastern), February 19, 2020.

- III. **APPENDIX REVISIONS**. Appendices M and N of the Local Rules of Bankruptcy Procedure for the District of Connecticut are revised in the following manner:
 - **APPENDIX M**: Revised to <u>add</u> a "Motion to Redact" to the list of motions that do not follow contested matter procedure and *may* be set for hearing. Additional text was added to the title of this appendix to clarify that the items listed *may* be set for a hearing.
 - **APPENDIX N**: Revised to <u>remove</u> a "Motion to Redact" from the list of exceptions to the contested matter procedure and *shall* be set for hearing. Additional text was added to the title of this appendix to clarify that the items listed *shall* be set for a hearing.
 - Both appendices also received stylistic updates that did not otherwise affect their substantive content.
