ORDER APPROVING BID PROCEDURES FOR A PUBLIC SALE OF REMNANT ASSETS AND SCHEDULING AN AUCTION AND FURTHER HEARING

Upon the Second Amended Motion of Kara S. Rescia, Trustee in the above-captioned case ("Trustee"), for Order Approving the Sale of Certain Assets of the Debtor's Estate, Subject to Higher Offers, Free and Clear of Liens, Claims, Interests, and Encumbrances Pursuant to 11 U.S.C. ORDERED: The Motion is granted in part and the Remnant Assets, as defined in the Motion (and as discussed during the December 13, 2023 hearing to clarify that any tax refund owed to the estate for the 2015 tax year is excluded) will be sold free and clear of all liens and encumbrances pursuant to 11 U.S.C. § 363(f), subject to a further hearing scheduled for JANUARY 24, 2024, at 10:30 a.m., pursuant to the process described in the Motion and as stated hereafter; and it is further

ORDERED: The Trustee shall serve the form of Notice of Proposed Public Sale of Estate Property as set forth as Exhibit "B" to the Motion ("Notice") with clarifications discussed during the December 13, 2023 hearing including that the deadline to submit higher offers to the Trustee or to file objections to the proposed sale with the Court is JANUARY 19, 2024, at 4:00

p.m., along with a copy of this Order, as set forth in Paragraph 28 of the Motion no later than three (3) business days after the entry of this Order; and it is further

ORDERED: The Trustee shall shall also state in the Notice of Proposed Public Sale of Estate Property that any auction of the Remnant Assets will be held before this Court on JANUARY 24, 2024 at 10:30 a.m., with the hearing to approve the winning bidder as the purchaser to also be held on JANUARY 24, 2024 at 10:30 a.m.; and it is further

ORDERED: If a Competing Bid, as described in the Motion, is timely submitted to the Trustee by no later than JANUARY 19, 2024 at 4:00 p.m., then the Court shall conduct an auction in open court on JANUARY 24, 2024 at 10:30 a.m. ("Sale Hearing"), at the United States Bankruptcy Court, 157 Church Street, 18th Floor Courtroom, New Haven, Connecticut, at which Oak Point Partners and any party submitting a timely Competing Bid may participate. The auction will proceed with a single round of sealed bids to determine the highest bidder, as well as the second highest bidder in the event the highest bidder defaults. And it is further
