Overview

The United States Bankruptcy Court for the District of Connecticut is accepting applications for a term law clerk who will support a Bankruptcy Judge for a term of one year with the possibility for an extension of an additional year. The position will begin approximately September 16, 2024.

The law clerk reports directly to the judge and is primarily responsible for conducting legal research, advising the judge on legal matters, preparing bench memos, drafting orders and opinions, editing and proofreading the judge's orders and opinions, verifying citations, prepare pre-hearing/trial case summaries, and attending trials and other court proceedings.

Required Qualifications

To qualify, eligible candidates must have graduated from an accredited law school with a strong academic background. A strong work ethic and excellent organizational, communication, analytical, and research/writing skills requested. Applicant must possess proficient typing and computer skills, ability to work with strict deadlines within a fast-paced environment, and ability to work independently or as a team player.

Preferred Qualifications

Familiarity with electronic case management and electronic filing processes. Additionally, although the Court will accept applications from candidates with all levels of experience, membership (in good standing) with a State Bar, at least one year of full-time post J.D. legal experience, and genuine ties to New England, particularly Connecticut, are pluses.
