**1. REVISED LOCAL FORM 420B NOTICE OF OBJECTION TO CLAIM**

The Court's Local Form 420B Notice of Objection to Claim is revised to include two additional fields allowing a user to input the name of a claimant(s) and a claim number(s).

The revised form is available on our website under "Local Forms" and a sample printout is attached to this announcement.

**2. NEW NOTICES OF PRO SE FILER/LITIGANT APPEARANCE**

Effective for use immediately, the Court has approved two local forms for a *Pro Se* Filer/Litigant to file a notice of appearance in a bankruptcy case and a notice of appearance in an adversary proceeding.

Please note that a *Pro Se* Filer/Litigant who files a bankruptcy petition that commences a Bankruptcy Case or files a complaint to commence an Adversary Proceeding is not required to file a notice of appearance.


