**NOTICE TO THE BAR AND THE PUBLIC REGARDING TWO NEW REQUIRED LOCAL  
FORMS AND REVISIONS TO APPENDIX M AND APPENDIX N OF THE LOCAL RULES**

**PLEASE TAKE NOTICE** that the Court has adopted two new local forms that will be required when converting a Chapter 13 or Chapter 12 bankruptcy case to Chapter 7. The forms are:

1. Debtor's Notice of Conversion of Bankruptcy Case from Chapter 13 to Chapter 7 Pursuant to 11 U.S.C. § 1307(a) and Fed. R. Bankr. P. 1017(f)(3). [Connecticut Local Form CTB-LF240 dated 07/2022], and
2. Debtor's Notice of Conversion of Bankruptcy Case from Chapter 12 to Chapter 7 Pursuant to 11 U.S.C. § 1208(a) and Fed. R. Bankr. P. 1017(f)(3). [Connecticut Local Form CTB-LF241 dated 07/2022].

The two new local forms are effective July 11, 2022, and are available on our website at <https://www.ctb.uscourts.gov>.

**PLEASE TAKE FURTHER NOTICE** that Appendix M and Appendix N of the Local Rules have been revised to include additional items on each appendix. The revised appendices are effective immediately.

- Motion to Withdraw Appearance
- Notice of Final Cure Mortgage Payments
- Notice of Proposed Abandonment
- Notice of Conversion from 13 to 7 pursuant to 11 U.S.C. §1307(a) and Fed. R. Bankr. P. 1017(f)(3)
- Notice of Conversion from 12 to 7 pursuant to 11 U.S.C. §1208(a) and Fed. R. Bankr. P. 1017(f)(3)

- Motion to Determine Final Cure and Payment pursuant to Fed. R. Bankr. P. 3002.1(h)
